Naturalist News By Roxie Campbell, Park Naturalist

Sometimes, people ask park staff, "What do you do in the winter time?" It seems that they can't imagine what there is to do when there are not a lot of visitors in the park. Well, I can answer that question pretty well by talking about what we did in the last month!

Sarah and I attended 16 hours of RS2 training RS2 is our on-line reservation system and cash register system which was upgraded statewide. We conducted interviews to try to fill our vacant full-time maintenance worker position for Rock Bridge. The first attempt did not yield a hiring and we just completed interviewing the second group of candidates.

Although the weather has not permitted us to conduct any prescribed burns yet this season (fall 2021 - spring 2022), I led volunteers in several work sessions to complete fire lines. I worked on plans for spring field trips by communicating with teachers and volunteer naturalists. (we are back to normal). FoRB's Bethany Haid and I met to coordinate ways to reach out to our community and educate children about the park. I prepared a PowerPoint and was scheduled to present it at the Missouri

Natural Resources Conference, but due to a snow storm I didn't attend or present. Volunteer Steve Ferguson and I worked with volunteers on how to use the web-based system for signing up and recording hours and we have planned two sessions to introduce new volunteers to the opportunities available to them. I met with three seasonal employees who are lined up to work the summer months to discuss work plans.

Sarah submitted budget requests complete with specifications and ordered toilets and other supplies (harder than it used to be). She conducted an assessment of the condition of all 56 bridges on our section of the Katy Trail. She requested bids for replacement of the roofs of the two maintenance buildings and planned the public meetings for all four of the parks she manages. Sarah provided chainsaw training for several volunteers and supervised volunteers in doing trail maintenance.

There is not space to list it all, but this gives you an idea of the kind of tasks park staff have to do in winter in order to take care of park resources and be prepared to provide services to visitors during the rest of the year.
